Are you the singing sensation of Kern County? Can you perform before a live Crystal Palace audience as well as hundreds of thousands of TV viewers? If you answered yes to both of these questions, ACAP Productions, KGET-TV 17 and KUZZ radio invite you to enter the "KEEP OLD GLORY FLYING" Salute to America in Song Talent Contest. Simply comply with the following contest rules and regulations and if chosen, you will be allowed to showcase your vocal talents at the annual Veterans Day celebration and tribute to be held at Buck Owens' Crystal Palace on Saturday, November 8th, 2008.

OFFICIAL RULES FOR PATRIOTIC SONG CONTEST SALUTING AMERICA

In order to enter this competition you must comply with the following eligibility requirements and agree to the terms set forth herein:

- 1) **Residence:** You must have been a resident of Kern County for at least one week prior to the date of this notice;
- 2) **Age:** Any individual aged fourteen (14) years and over is allowed to enter. If you are a minor above the age of fourteen but under the age of eighteen, only your parent or legal guardian can download any information, and you must have parental or legal guardian consent allowing your participation in the auditions and the final performance. You must be accompanied by your parent or legal guardian at all appearances. Proof of the contestant's age and identity must be brought to the auditions;
- 3) **Ethnicity:** Contestants of all races, creeds, heritages, nationalities and backgrounds are encouraged to participate;
- 4) **Gender:** Both females and males are eligible to be chosen;
- 5) **Prior Experience:** Amateur or professional status is not important and individuals from both categories are invited to enter;
- 6) **Availability:** You must be available for three rounds of auditions and tryouts and rehearsals commencing April, 2008 and culminating in the live TV appearance on November 8th, 2008;
- 7) **Entrance Fee:** There is no entrance fee or purchase fee required and this contest is void where prohibited by law;
- 8) **Winners:** The number of winners chosen to perform will depend on the amount of talented individuals participating and the decision of the judges, who will be chosen from the community by ACAP Productions, will be final;
- 9) **Demos:** Any audition demo sent for review by the judges will become the property of ACAP Productions and will not be returned to the entrant;

If you are in agreement with all of the above, then proceed to enter the talent search audition process in the following manner:

Go to the KGET-TV 17 website at www.KGET.com and click on the link "Talent Search". Print out and sign the CERTIFICATE OF ELIGIBILITY AND PUBLICITY RELEASE and enter all of your personal information as directed, especially the best contact information we would need to be able to reach you. From there you are instructed to send in only one song, in MP3 format, you have sung on a CD, for your initial audition. The song can be of any musical genre, however, it should be remembered that if chosen as a finalist you will be performing only patriotic songs during the live telecast. Mail the CD labeled with your first and last name, along with your signed Certificate, to KGET-TV 17, 2120 L Street, Bakersfield CA 93301. On the outside of the envelope write the words "TALENT SEARCH". You must complete this initial phase so that KGET receives your demo no later than May 19th, 2008. Multiple songs and/or video will not be accepted.

If you are one of the contestants chosen to proceed to the next level of competition, you will be notified by email and/or phone by June 2nd, 2008 telling you when and where your first live audition will take place. No phone calls to KGET, KUZZ or ACAP Productions will be accepted unless you have first been contacted as a finalist. You will then be instructed to pick up from the KGET-TV 17 Studio a packet containing both a vocal and instrumental CD of a patriotic song you will required to sing at the next audition (for your benefit we will also include a printout of the words in the song). In order to obtain this packet, you must show valid ID if you are an adult and have your parent or guardian with you if under the age of eighteen. You will perform this song live before a panel of judges selected by ACAP Productions.

All contestants must sign a release and waiver form prior to admission to the tryouts and auditions by which they agree to hold ACAP Productions, Inc., KGET-TV 17 and Clear Channel Television, and KUZZ radio, and other affiliates, officers, directors, partners shareholders and agents of same not liable for any claims resulting from participation in the Contest and to hold ACAP Productions, Inc., KGET-TV 17 and Clear Channel, and KUZZ radio and the respective shareholders, directors, employees agents and representatives of each of them harmless from and against any and all claims or liability arising directly or indirectly from the prize or participation in the Contest. You can pick up this release and waiver when you obtain the packet and it must be duly signed before you attend the first audition.

Those selected from this audition will advance to the final round, which will take place on Tuesday evening, July 29th, 2008, before a live crowd of regular patrons at Buck Owens' Crystal Palace. Final contest winners will be notified by August 4th, 2008, and then given a list of the songs they will be required to perform at the KEEP OLD GLORY FLYING tribute. Rehearsal dates will then be set once all the finalists have been chosen.

Winners chosen to be part of the tribute will be announced in Bakersfield Magazine, interviewed on KGET-TV 17 News at Sunrise, receive two complimentary tickets to the event, and, of course, the chance to showcase his or her talents on live TV throughout Kern County, and finally, a DVD of their performance. Payment of all federal, state and local taxes is the sole responsibility of the winners. ACAP Productions is responsible to submit an IRS form 1099 or the equivalent for any individual who wins \$600 (or the equivalent of same) or more in any calendar year.

We reserve the right to disqualify and/or exclude, in our sole and absolute discretion, any individual from any of the auditions for any reason or for no reason at all, including without limitation, violation of any portion of these rules, or tampering with the entry process or the audition process. We also reserve the right to change the rules and procedures at any time. Being chosen to audition and/or compete at any level in the process does NOT ensure that you will be selected to the final stage.
